master for all employees. Since this team has come together (in early 2007) we have had the most accurate financial reporting since the beginning of the first SFC farm (1998). Procedures and reporting systems have been put in place to ensure that the Board of Directors and top management are now fully informed on all activities on each of the farms, including acreage cleared, crops grown and status of machinery.

Every SFC farm has a Manager who gives general oversight of the farm to which he is assigned. He is provided with a house outside the farm compound.

Cal Bombay Ministries and the Savannah Farmers Cooperative strive to provide on-going training for our farm managers, both in agriculture and in administration.

Chairman of the Board –

The Hon. Mr. Steven Wondu Ambassador from Sudan to Tokyo, Japan. He was formerly Ambassador to the USA, the UN and Canada on behalf of Southern Sudan. He was Auditor General of southern Sudan during the only 11 years of peace they had between 1956 (independence) and 2005 (when the Comprehensive Peace Agreement (CPA) – between north and south –was signed). He is a Chartered Public Accountant (USA).

Managing Director – The Hon. Mr. Zamba Duku. Mr. Duku is Speaker of the Central Equatoria State Legislative Assembly. He also acts as Managing Director of the Savannah Farmers Cooperative and conveys the wishes of the Board of Directors directly to our General Manager, and to our Accountant and book-keeper. He held the position of Brigadier General during the war years.
